Background

At its Meeting held on 21st May 2015 Council resolved as follows:

In view of the major reduction in the GRV Mine-sites and GRV SPQs and the reduction in the UV Mining Tenements the President and Acting Chief Executive Officer received approval from the meeting the make a deputation to the Department of Local Government and Communities to seek its advice as to whether the Minister would approve the requested Differential Rates.

Comment

The President and ACEO attended a meeting in Perth on Tuesday 15th June 2015 where the Shire's request for Differential was discussed. It was the outcome of the meeting that the Ministerial staff of the DLG&C would recommend that the Minister reject Council's request. From there a compromise was sought and found being the GRV Min-sites and GRV SPQs be further reduced by 7.5c to 22.5c in the \$.

It was pointed out that this was a reduction of 17.5c in the \$ or 43.75% on the 2014/15 rate.

The proposed Differential Rates were advertised in the West Australian Newspaper and the Merredin Mercury and at the close of the receipt of submissions three (3) were received. They were from Cliffs, Hanking and the Chamber of Minerals and Energy.

Copies of the submissions (previously circulated) and a report by the ACEO on these submissions are attached.

Background

An un-budgeted transfer to Reserves needs to be treated as any other proposed payment that hasn't already been included in Council's budget. Background

While Fleetwood has been awarded the tender to construct the four new transportable Lifestyle Accommodation houses for the Shire to be placed on the 4 lots fronting onto Canopus Street, Southern Cross, the Shire still needed earthworks and the supply and installation of utility services to be carried out prior to the houses being delivered to site. A second tender (Tender R02-2014/2015) was advertised in the West Australian newspaper on Saturday 30th May 2015 to carry out Earthworks, and the supply and installation of Concrete Works, Hydraulic Services, and Electrical Services for the Lifestyle Accommodation Development consisting of 12 residences in Southern Cross. The tender closes at 12:00 noon on Wednesday 17th June 2015.

Comment

Tender documents have been forwarded to 13 companies, and at this time it appears that at least 2 companies are interested in the project as they either have or intend to come to site to look at the location in order to prepare a tender submission. The Project Manager, Mr Simon de Been of Kal Engineering Consultants, was on-site Friday 12th June to meet with interested tenderers and discuss the project and answer any questions they had.

The Project Manager has carried out part of the assessment process but still needs to complete the financial and reference checks of the two tenderers. In saying this, based on the assessment so far, the Project Manager's preferred Tender is A & Wright Pty Ltd who has scored better on the weighted evaluation assessment. Attached is an E-mail report from the Project Manager as a spread sheet of the evaluation results.

As a full evaluation of the tenders cannot be presented to Council for a formal decision, it is recommended that Council accept the preferred tender and the Acting Chief Executive Officer be authorised to sign the contract once the evaluation has been completed. Under Section 543 (b) of the Local Government Act 1995 Council is not able to delegate authority to the Acting Chief Executive Officer to accept a tender over the delegation limit. Alternatively a Special Meeting of Council could be held to formally accept a tender. This will enable the project to continue rather than waiting until the July Council Meeting for a decision.

In terms of when the tenderers commencement and completion time:A & P Wright Pty Ltd – commence mid-August 2015 – completion mid-November 2015;
BCL Group Pty Ltd – commence 5th July 2015 – completion 20th September 2015.
Speaking to Fleetwood they can re-schedule the construction work of the houses to be in-line with these works being completed in December or otherwise make provisions to store the houses on their site.

An advantage in waiting to commence this work and accepting A & P Wright's tender is that they would only be working on this project and therefore not splitting resources with other projects; it would allow for the Southern Cross Caravan Park Upgrade project designs and specifications to be completed and then go to tender with the good possibility that they would tender for that work while here; A & P Wright are a plumbing and drainage company originally but have branched out to provide other services; and it allows time for the town planning re-zoning process to be completed.

The Project Manager has advised that both BCL Group Pty Ltd and A & P Wright Pty Ltd can carry out the works satisfactorily.

Council has allocated a total of \$1,501,780 for the whole project and is committed by acceptance of the Tender for 4 houses for \$837,600. There has been a claim for "extras" (omissions by the tenderer) of approximately \$145,000, and some minor costs such as Town Planning and Project Management costs amounting to approximately \$30,000.

The acceptance of this Tender at \$730,450 will cause an over-run of the Budget of \$150,992 plus any agreed settlement of the "extras" claimed.

Council has little choice but to accept the over-run and accept the Tender.

The matter of the claim for "extras" regarding the housing tender will be dealt with at the July 2015 Council Meeting.

The DCEO has included expenditure of \$1,671,000 in the Draft 2015/2016 Budget for this project.
