Purpose of Report

To consider the fees & charges to be applied in 2017/18

Background

The Local Government Act 1995 requires fees and charges that are to be imposed during a financial year to be adopted with the annual Budget.

As the Budget will not be adopted until after 1st July 2017 Council is requested to consider the fees and charges prior to the Budget adoption so that the agreed fees & charges can be taken into consideration when preparing the Budget and to allow the fees & charges to be applied from 1 July 2017.

Comment

A copy of the current fees & charges and proposed changes are included in the attachments. The items in Red are proposed to be deleted and the items in Green are proposed to be included.

The proposed changes are as a result of the fees & charges having been reviewed by executive staff. A summary of the recommended changes follows:

- Remove Notice of Discontinuance and Proof of Debt Paid as these are not used
- Increase the costs of Title Searches to ensure the Shires costs are fully recovered.
- Increase the costs of Animal Destruction
- Remove the numerous Offensive Trades fees as these are set by regulation and are rarely used
- Split the Health (Public Building) Regulations 1992 fees into three categories
- Increase the costs of internet access and scanning
- Remove the Overdue Notice Fee for the first notice and have one fee for further overdue notices
- Remove the fee for 13a Libra as it is not available for hire
- Change the refuse disposal fees from per tonne to per cubic metre

- Increase the costs of niche wall placements to ensure Shire costs are recovered
- Remove the Annual Septic service license as it is not used
- Remove the Planning Fees as they are set by regulation
- Include an Extra Cleaning Fee for the Community Centre to cover the costs of extra cleaning if the facility is left in a messy state
- Remove the Ground Hire Stock Yards overnight hire fee as it is not used
- Correcting the Community Bus fee as is should include fuel
- Remove the Hire of Tables and Chairs (Recreation Complex Only)as it has been included twice
- Remove the Swimming Pool Admission fees
- Remove the Building Application fees as they are set by regulation
- Introduce a Lost key fee for the caravan park to cover the costs of getting replacement keys cut

Statutory Environment

- 6.16. Imposition of fees and charges
- (1) A local government may impose and recover a fee or charge for any goods or service it provides or proposes to provide, other than a service for which a service charge is imposed.
- (2) A fee or charge may be imposed for the following —
- (a) providing the use of, or allowing admission to, any property or facility wholly or partly owned, controlled, managed or maintained by the local government;
- (b) supplying a service or carrying out work at the request of a person;
- (c) subject to section 5.94, providing information from local government records;
- (d) receiving an application for approval, granting an approval, making an inspection and issuing a licence, permit, authorisation or certificate;
- (e) supplying goods;
- (f) such other service as may be prescribed.
- (3) Fees and charges are to be imposed when adopting the annual budget but may be —
- (a) imposed during a financial year; and
- (b) amended from time to time during a financial year.
