# 5 2018/2019 Budget Overview

The Shire President requested the A/CEO to give a brief overview of the processes in the development of the Draft 2018/2019 Budget.

The A/CEO advised Councillors that all Managers had provided input into the presented document, particularly relating to proposed expenditure from their respective portfolio's. The Executive Manager Corporate Services (EMCS) had then formatted the Budget document for presentation to Council.



The A/CEO advised that Council's Senior Managers had workshopped the Draft Budget on two occasions to ensure that the presented Draft covered all aspects of anticipated income and expenditure for 2018/2019.

Following the above overview the A/CEO requested the EMCS to update Councillors on the presented Draft Budget. The EMCS highlighted the following matters for Councillors information:-

- Draft Budget incorporates a 1.5% rate increase;
- \$1.2M pre-payment of 2018/19 FAG Grants were received in the 2017/18 financial year which overstates Councils Net Current Position at year commencement;
- Had provided \$84,564 as anticipated expenditure relating to the 2017/18 financial year for commitments relating outstanding Purchase Orders; and
- Advised Councillors that the Draft Budget position had improved by \$22,000 as income for the Community Resource Centre had been understated;

The EMCS also provided Councillors with an overview of major capital expenditure items that were contained with the Draft Budget.

Following the above presentation the Shire President invited input from Councillors in relation to any aspects of the presented document.

# **Statutory Environment**

#### Local Government Act 1995

# 6.2. Local government to prepare annual budget

- (1) During the period from 1 June in a financial year to 31 August in the next financial year, or such extended time as the Minister allows, each local government is to prepare and adopt\*, in the form and manner prescribed, a budget for its municipal fund for the financial year ending on the 30 June next following that 31 August.
  - \* Absolute majority required.
- (2) In the preparation of the annual budget the local government is to have regard to the contents of the plan for the future of the district made in accordance with section 5.56 and to prepare a detailed estimate for the current year of
  - (a) the expenditure by the local government; and
  - (b) the revenue and income, independent of general rates, of the local government; and
  - (c) the amount required to make up the deficiency, if any, shown by comparing the estimated expenditure with the estimated revenue and income.
- (3) For the purposes of subsections (2)(a) and (b) all expenditure, revenue and income of the local government is to be taken into account unless otherwise prescribed.
- (4) The annual budget is to incorporate
  - (a) particulars of the estimated expenditure proposed to be incurred by the local government; and
  - (b) detailed information relating to the rates and service charges which will apply to land within the district including
    - (i) the amount it is estimated will be yielded by the general rate; and
    - (ii) the rate of interest (if any) to be charged by the local government on unpaid rates and service charges;

and

- (c) the fees and charges proposed to be imposed by the local government; and
- (d) the particulars of borrowings and other financial accommodation proposed to be entered into by the local government; and
- (e) details of the amounts to be set aside in, or used from, reserve accounts and of the purpose for which they are to be set aside or used; and
- (f) particulars of proposed land transactions and trading undertakings (as those terms are defined in and for the purpose of section 3.59) of the local government; and
- (g) such other matters as are prescribed.
- (5) Regulations may provide for —



- (a) the form of the annual budget; and
- (b) the contents of the annual budget; and
- (c) the information to be contained in or to accompany the annual budget.
